All foreign exchange transactions are subject to the applicable Goods and service Tax (GST), which is payable in addition to the charges mentioned above.

Presently, the applicable rate of GST is as under: -

- On amount of commission, fees and charges paid - @18% of the amount of the commission/fees/charges.
- On amount of foreign currency exchanged as per below slab:
